

SUMMARY ANNUAL REPORT

For Tanium Inc. Group Health And Welfare Benefits Plan

This is a summary of the annual report of the Tanium Inc. Group Health And Welfare Benefits Plan, EIN 26-0340021, Plan No. 501, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Tanium Inc. has committed itself to pay certain self-insured Medical, and Dental claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Ace American Insurance Company, Vision Service Plan, Hawaii Medical Service Association, Telus Health, Kaiser Foundation Health Plan Of Washington, Life Insurance Company Of North America and Kaiser Foundation Health Plan, Inc. to pay Medical, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, and Business Travel Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$2,525,460.
